1. Apologies for Absence

- 2. **Declarations of Interest by Councillors on any items on the Agenda.** KL standing declaration of interest on all planning matters.
- 3. Approval and signing of Minutes from the meeting of 25th October 2023. Approved.
- 4. **Presentation** Montgomeryshire Wildlife Trust (Ceri Jones Head of Living Landscapes) Planned start date for river restoration is summer 2024, this will be funded by a Heritage Lottery Fund grant. However, the project is at risk due to damage on the site such as gravel being moved, deep tracks through the reserve and trees being removed. These actions increase the risk of flooding and have resulted in research costs already incurred of over £10,000 needing to be respent. The culvert is also damaged and will be repaired by Powys CC. The fence also needs to be repaired an offer to repair this has been made by MWT. This damage may result in prosecution by NRW and MWT. A licence should be sought if gravel is to be removed. KL to continue discussions with resident responsible to hopefully resolve this ongoing situation.

This is one of the biggest river restorations in the UK and will hopefully still go ahead. KL raised a residents concern that trees on MWT land are blocking the view from their property, MWT responded that if these trees are removed the river is more likely to flood causing damage to property. However, pollarding is a viable option. The CC requested that the footpath is re-instated, the trees blocking a property view are pruned and the drain is cleared. Funding will hopefully be available for work to repair damage and reinstate pathways by April 2024.
